Individuals from across Canada who have experience in one or more of the following areas are encouraged to apply:

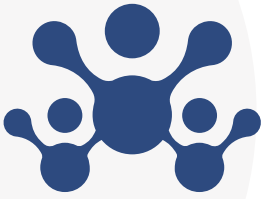
- Duchenne clinical care
